

PETITION FOR IN-STATE TUITION CLASSIFICATION CHECKLIST

The Colorado Tuition Classification Statute (C.R.S 23-7-101 et. seq) delegates responsibility to the college to determine eligibility for in-state tuition in accordance with rules that apply to all public colleges ad universities in the state. The statute states that each student must document domicile (a fixed and permanent residence for 12 continuous months preceding the beginning of the term) and intent (legal ties with the state). Students under the age of 23 whose parents are not Colorado residents, and who are not married, must prove emancipation.

You must submit all checklist items that apply to you. Documentation submitted must be photocopies of your original documents because the entire petition becomes permanent record and is retained by the college. Please note: this checklist has been provided to assist you in the residency petition process and <u>does not imply that your petition will be approved.</u>

Domicile documentation:

□ Copy of leases or rent receipts. Homeowners should include a copy of a warranty deed. If you lived with a friend or relative, you must provide a *notarized* statement from that person indicating the property address and the dates you lived with him/her. You must also provide a copy of their lease, deed or rent receipts

Intent documentation:

- □ Copy of most current Colorado Income Tax Returns
- Copy of Voter registration
- Copy of Drivers License or Identification Card issued by Colorado
- Copy of Motor Vehicle registration
- Verification of Employment

Emancipation documentation:

- Emancipation form completed and signed by parents (must be notarized)
- □ Copy of both parents Federal Income Tax returns for the most current year
- □ Your most recent pay stub and W-2's for the most recent year
- □ Copy of your Federal Income Tax Returns for the most current year
- □ Copy of Marriage License (if applicable)
- □ Copies of monthly bank account statements, verification of local bank account, trust account statements
- Copy of Colorado High School Diploma or transcript

Other documentation:

- □ Copy of resident alien card or other INS documentation as listed in packet
- Copies of form 2555 from your Federal Income Tax Returns for years of foreign address
- □ Copy of DD214, most recent LES, DD-2058 (if applicable)
