

Trinidad State Junior College Student Government Office Petition

The Trinidad State Junior College study body gives the power of representation and governance to the members of the Student Government Association. The officers of SGA are duly elected by the student body and have all rights and privileges that accompany the offices for which they are elected. Students holding offices must maintain the standards and uphold the policies of Trinidad State Junior College, on and off campus. The demeanor, attitude, reputations, and actions of all officers are expected to meet the standards as prescribed in the Codes of Conduct and policies established by Trinidad State Junior College, the Student Government Association, the administration, the Office of Student Life and the State of Colorado.

The Executive Officers shall be vested with the power of the student body and seriously consider proposals which may diverge from the traditions and customs of student life at Trinidad State Junior College. The officers must meet the following requirements to serve at the pleasure of the study body of TSJC. Each candidate for office:

- ✓ Must have and maintain a grade point average of **2.5** (this rule does not apply to incoming Freshmen)
- ✓ Must be in good standing academically and under disciplinary policy.
- ✓ Must not have had any disciplinary action taken against him or her.
- ✓ Must be enrolled in at least **9** credit hours.

If elected to an Executive Office in the SGA, officers must:

- ✓ Keep office hours.
- ✓ Attend and work at all official SGA and Student Activities functions.
- ✓ Serve on college and departmental committees and boards.
- ✓ Maintain a standard of conduct that is above reproach.
- ✓ Uphold the rules, regulations, policies and laws of Trinidad State Junior College, the State of Colorado, and the United States of America.
- ✓ Seek and consider the advice and counsel of the SGA Advisor, Dean of Student Services, and the President of the College.
- ✓ Will leave all administrative, policy, and financial matters to the administrator of the area (the Coordinator of Student Activities).
